An emergent meeting of the Guru Nanak College Governing Council was held today, **Monday 5th May, 2025** in the Chamber of the Secretary at **1.00 P.M.**, in the Women's Wing of the College. Sardar R. S. Chahal, President, was in the chair.

Proceedings:

As for the agenda today, the issue of gross indiscipline of the Principal Dr. Sanjay Prasad, and various other irregularities committed by him was discussed at length. The President Sardar R. S. Chahal narrated the entire issue, and cited the example of Dr. Varsha Singh's case, and other specific cases.

The entire Governing Council was unanimous that it was an act of gross indiscipline committed by the College Principal and his action amounts to challenging the authority of the management, i.e., College Governing Council. Everyone presents, including the Teachers' Representative, called for, and supported strict action against the Principal Dr. Sanjay Prasad. It was unanimously decided to put Dr. Sanjay Prasad, Principal under suspension. It was decided to issue a charge sheet to him within ten days. During the period of suspension, Dr. Sanjay Prasad will be barred from coming to the College unless called for, and he will seek permission for leaving headquarters from the Secretary. And during the period of Suspension, Dr. Sanjay Prasad will be entitled to getting subsistence allowance as per university rules.

As an issue arising out of the main agenda of the emergent meeting dated 5th May 2025, it was decided to give additional responsibilities to

- a) Dr. Ranjana Das, Prof. In-Charge, Women's wing, i.e., (1) Financial powers and authorities of the Principal and (2) all official correspondence of college in addition to her role as Prof In-Charge of the Women's wing.
- b) It was decided to appoint Sri Dipak Kumar as Prof. In-Charge of the Bhuda Campus of the College replacing Prof. Amarjit Singh. Sri Dipak Kumar will however function under Dr. Ranjana Das.
- c) It was decided to request Ms. Sadhana Kumari Singh to assist Sri Dipak Kumar in day-to-day affairs. It was decided to request Dr. Varsha Singh to assist Dr. Ranjana Das in the Women's Wing in day-to-day business,
- d) Ms. Sadhana Kumari Singh, and Snehal Goswami would be appointed Bursar- I and Bursat – II, replacing Sri Sanjay Kumar Sinha.
- e) Also, it was decided to appoint Sri Daljeet Singh as Controller of Examinations of the College replacing Sri Dipak Kumar.

All the above decisions will come into force with immediate effect i.e., from the afternoon of 5th May 2025.
